#### **COURSE DESCRIPTION**

At a time when there is a myriad of opinions about almost everything, and so many people who quote Quran and Sunna to promote their own interpretations of Islam, it has become more important than ever to equip ourselves with the ability to discern right from wrong. *Uṣūl al-Fiqh* is a science which outlines the methodology that must be used by anyone who attempts to pronounce the Islamic legal ruling on an issue. Learning *Uṣūl al-Fiqh* not only gives us an understanding and appreciation for the process of *ijtihad*, but also empowers us to evaluate the legitimacy of a legal opinion. In this course you will learn about the meaning and types of *al-Ḥukm al-Sharʿi*, the sources of Islamic Law, the rules of interpreting sacred texts, the higher objectives of Islamic law [maqāṣid al-sharīʿa], legal maxims [al-qawāʾid al-fiqhiyya], and the status of innovation [bidʿa] in Islam.

#### **COURSE OBJECTIVES**

- 1. To realize how little we know, and how much we need to learn.
- 2. To appreciate the richness, complexity, and precision of the Islamic scholarly tradition.
- 3. To distinguish normative Islam from its aberrant interpretations.
