### COURSE DESCRIPTION

In this course the students will trace the development of Islamic Law from the era of the Prophet ﷺ through the early generations until the emergence of the Four Schools of Sunni Jurisprudence. Class discussion will include:

- Fiqh During the Era of the Companions
- Fiqh During the Era of the Successors
- The Life & Times of Imam Abū Ḥanīfa
- The Life & Times of Imam Mālik
- The Life & Times of Imam Shāfiʿī
- The Life & Times of Imam Aḥmad
- Causes of Disagreement Among Scholars
- *Ijtihād & Taqlīd* in Islamic Law

### COURSE OBJECTIVES

1. To understand the value of the Four Schools in Sunni Islam
2. To appreciate the existence of scholarly disagreement
