Candidate qualifications in accordance with IACC constitution article 7 guidelines:

1. The Candidate must be a registered member of IACC.
2. Candidates for the office of Ameer must have resided in Collin County for at least past two years consecutively by October 11, 2018.
3. Candidates for the office of Shura Member must have resided in Collin County for at least past one year by October 11, 2018.
4. Candidates running for the office of Ameer shall not hold or accept any position such as Chairman, Chairman-Elect, President, Vice President or Treasurer of any other Islamic/Muslim non-profit organization.
5. The candidates and nominators must be practicing Muslim & frequent attendee of the IACC.

Additional rules and regulations:

1. By signing this nomination form the nominee must have read the rules and consent to abide by them. Candidates that do not abide by these rules may be subject to disqualification.
2. A Candidate can only contest for either Shura member or Ameer Positions. Any candidate nominated for Ameer AND Shura position will be disqualified for both positions.
3. Nominations forms will only be accepted if signed by both candidate and nominator. Nomination form shall be submitted in a drop-box at IACC main office.
4. Candidates and any surrogates of the candidates shall not be allowed to solicit/campaign within the perimeter of IACC property.
5. All candidates must adhere to section 2.1 of IACC constitution and as further clarified in the “Declaration of Faith” document.
6. All candidates must sign of the consent form for a “Background Check” by the Election commission. The background check will be performed on the final list of candidates nominated for the Shura and the Ameer positions. The candidates must agree to provide their full name/aliases, date of birth, driver’s license number and social security number on or before October 24, 2018. Candidates not adhering to this policy shall be automatically disqualified as a candidate.
